2. The applications were invited through "AICTE Internship Portal" from students studying in,-

- (1) 5 Years Law Course (Students studying in 4<sup>th</sup> and 5<sup>th</sup> Year) - 6 students (3 Male and 3 Female);
  - (2) 3 Years Law Course (Students studying in 2<sup>nd</sup> and 3<sup>rd</sup> Year) - 2 students (1 Male and 1 Female); and
  - (3) LL.M. Course (Students studying in 1<sup>st</sup> and 2<sup>nd</sup> Year) - 2 students (1 Male and 1 Female).
3. Ten students were selected on the basis of the following criteria:-

- (1) In order to give an opportunity to students of different Law Colleges/ Universities in the State of Maharashtra 10 students from 10 different Colleges/ Universities are selected.
- (2) One student from one Law College/ University is selected.
- (3) Selection is based on MH-CET/ CLAT Marks.
- (4) From 5 Years Law Course 6 students are selected (3 Male and 3 Female).
- (5) From 3 Years Law Course - 2 students are selected (1 Male and 1 Female).
- (6) From LL.M. Course - 2 students are selected (1 Male and 1 Female).
